I am a resident of Maple Ridge and have a disability and have had many problems for sharing the sidewalks with bikes. My disability is blindness, and I also travel wit a guide dog.

As I am walking to do my daily duties I encounter almost all the time bikes in the sidewalk.

The road I travel to catch a bus or to go to the bank is Doodeknee trunk Road. Because of these encounters witch is almost every time I am traveling on these sidewalks, I am forced to go to the road so I do not get hit with the bike. Guess what? then I am in trouble, because I can get hit with a car traveling at pretty hi speeds.

What do I do now if you allowed the bikes in the sidewalk?

Who is responsible to keep me safe then?

The bikes I encounter are driven by students from the West view high school.

This is not all I have encounter on my walks in the city of Maple Ridge.

On 123 Street I have also encounter a horse on the sidewalk which my dog took a fear and pushed me into the on coming traffic.

I am a resident of Maple Ridge, a tax payer and I have rights to travel on a side walk without being run over by a bike or a horse.

Bike lanes are for bikes not side walks. In my area there many seniors another blind persons and we all have to be at the mercy of the bike riders without any respect for walking persons, with a disability or seniors.

Pleas consider to not create a law which does not keep me safe and others.

Put bike riding in bike lanes and this concept is not that fourner, because in Europe pedestrians and bike with proper sidewalks exist to accommodate both.

If my rights are violated, and I lose my rights for being able to travel independently on a sidewalk, my next stop will be Human Rights.

Hello,

The Active Transportation Advisory Committee (ATAC) for the City of Maple Ridge is currently discussing the bylaw which allows bicycles on our sidewalks. I have had several seniors tell me informally they have experienced near misses and even in some cases collided with folks on bicycles. It is posing particular concern for those with hearing loss who may not be aware when someone is approaching them from behind and they are frightened at the last second.

Out of concern for pedestrians and downtown shoppers, the Downtown Maple Ridge Business Improvement Association has submitted a letter to Council, stating they would like to see this bylaw reversed back. Unfortunately, no one has made an official complaint to Council to date so it is difficult to prove this is a concern for City residents. We are asking seniors, business owners, moms, shoppers, and anyone who is concerned to report their experiences (near misses, bad experiences involving bicycles on the sidewalks) specifically in our downtown of Maple Ridge.

Subject: making sidewalks safe for pedestrians

Dear Mayor and Council,

The Canadian Federation of the Blind is a membership organization dedicated to the complete integration of blind people into Canadian society on an equitable basis. Blind people are pedestrians and therefore have a strong interest in pedestrian friendly cities.

Far too often, pedestrians, cyclists,, and skateboard riders are lumped into the general category of "people who don't drive." City planners tend to expect them all to coexist happily on sidewalks.

That plan doesn't always work well, especially not for pedestrians. Older people, those with mobility impairments, and blind individuals can find it difficult to share a sidewalk with a fast moving bicyclist, especially if the cyclist fails to respect pedestrians and assumes that they will always be the ones who move out of the way. Swiftly moving nearly silent vehicles constitute a safety hazard for blind people who rely on hearing to keep us safe.

We recommend the creation of bike paths separate from sidewalks wherever possible. In those cases where cyclists and walkers must share the same space, strong pedestrian friendly bylaws are essential. At the very least, any bicycle being ridden on a sidewalk should be required to emit continuous sounds sufficient to warn pedestrians of their presence.

Unless city bylaws incorporate safety measures to protect everyone who uses the sidewalks, pedestrians are liable to be injured and Maple Ridge is liable to be deemed to have contributed to those injuries.
