- Consider returning the hedge along the west property line to the rear of the building.
- Provide a pedestrian connection from both buildings to Lougheed highway and possibly 119th Avenue.
- Consider the use of porous paving in areas of the parking area .
- Consider low planting in between the second bank of car stalls.
- Consider traffic calming features in the parking area
- Consider addressing the street with the design of the southernmost retail unit.
