

The major goals of the OCP Environmental Framework Model are:

- 1. Protect Significant ecosystems in the municipality;
- 2. Anticipate and respond to impacts of climate change on land, water and air;
- Determine guidelines and standards necessary to protect and manage environmentally sensitive areas;
- Identify situations where additional environmental studies and BMPs are required as part of the sustainable development review process;
- 5. Maintain and improve ecosystem health and human safety.





- On April 17 2014, Council received the Environmental Management Strategy (EMS) as information;
- Council directed staff to prepare an initial EMS Implementation Report for consideration and endorsement. The focus was to be on short term high priority strategies outlined in the Strategy.





#### **Environmental Management Strategy Goals**

- 1. Conserve and Manage Natural Assets
- 2. Design & Build Sustainable Neighborhoods
- 3. Improve Communications & Awareness

Each goal has multiple strategies and action items


Figure 7 in the EMS and Appendices One in the report contains the consultant's list of Recommended Action Items/Priorities

#### **EMS** Report Considerations



- Recent consideration of an Environmental Sustainability
   Advisory Committee provides a forum for detailed review
   of the EMS with the assistance of community stakeholders;
  - Opportunities to work through details, provide input and review potential implications of the Strategy;

Therefore, the report recommends that the EMS be forwarded to the EnSAC for review prior to being submitted and recommended to Council.



### **EMS** Report Considerations



- Many of the short, moderate, and long term implementation items in the EMS may require more complex review of implications, supporting materials, budgets, and how they will need to be selectively phased in over time;
  - Opportunities to work with EnSAC through the details and potential implications of the more complex short, moderate, and longer term strategies or action items;

The report recommends that the majority of the short, moderate and longer term Action items in the Strategy are referred onto the EnSAC for further review prior to being submitted to Council.



### **EMS** Report Considerations



- 3. There were some short term high priority strategies and action items identified in the EMS by the consultant of record.
  - Prioritization was also based on feedback from Council, costs and benefits associated with impacts, and relative level of effort required for successful implementation;

Therefore, the report recommends that the short term high priority action items identified in the report be endorsed by Council to commence in 2015.

#### Recap



- 1. Council refers the *Environmental Management Strategy*, dated April 2014 to the Environmental Sustainability Advisory Committee for their review and possible endorsement. Once completed, the Committee would then forward the Strategy to Council for recommendation.
- 2. Planning will assist and support the proposed *Environmental Sustainability Advisory Committee* program which is likely to commence in 2015.
- 3. Work will commence in 2015 on the short term high priority items identified in Table 1 of the report.
- 4. Remaining short, medium and long term implementation items will be prepared in discussions with the Environmental Sustainability Advisory Committee prior to recommendation to Council.





#### **EMS Implementation Recommendations**



- 1. The report recommends that the *Environmental Management Strategy* of April 2014 be referred to the 'to be formed' Environmental Sustainability Advisory Committee for consideration, review, and recommendation to Council;
- 2. The report recommends that Staff be directed to prepare the remaining short, medium and long term action items from the EMS into a Final Implementation Strategy, in consultation with the Environmental Sustainability Advisory Committee and forward the recommendation to Council;
- 3. That short term high priority action items identified in Table One in the report entitled "Environmental Management Strategy Implementation Report Short Term High Priority Implementation Recommendations", dated November 3 2014, be endorsed by Council.
