The update also provided an overview of the Taskforce discussions, which included: energy step code, net zero carbon code, retrofits, and the future agenda items on green infrastructure and transportation. Environmental Advisor Committee members discussed the Climate Action Plan, the key deliverables derived from the plan, and the projected 17-month timeline of data collection and deliverables, which included a green house gas inventory, land use forecast, multi-hazard map, extreme temperature risk map, climate risk map, and low carbon resilience climate action plan.
