Subject: Sidewalk cyclists

To the Mayor and Council Members of Maple Ridge

It is my understanding that Maple Ridge has a by-law which permits cycling on sidewalks. I request that serious consideration should be given to rescinding this by-law. In my opinion, it is abused by most of the cyclists in the downtown area who think it is their right to weave in and out of pedestrians with no regard to the consequences.

Since moving to Maple Ridge eighteen months ago, I have witnessed many near misses. Last week, I was walking on the north side of the Lougheed Highway, east on the sidewalk from 222nd street. A blind person was walking down towards 222, keeping very close to the buildings. I moved over to give him plenty of room to walk in his comfort zone. When at shoulder level to him, I took a small step back from the very edge of the sidewalk to a regular position. I had just done that when I heard a swoosh and a young man on a mountain bike can speeding past me. As he passed his handlebars ran down the length of my arm from my elbow to wrist (I was holding my shoulder bag tightly).

I managed to maintain my balance but was shaken and my arm was very painful. Of course, he didn't stop or look back, just continued pedalling at high speed. He did yell "sorry" and laughed!

To have gained the speed he was travelling at when he past me, he must have been travelling full bore down the sidewalk from KFC and crossed 222 without stopping. This is typical of the people who are using the sidewalks to cycle in the downtown area. I have cycled since childhood but never on sidewalks. Bicycles are road traffic in my opinion.

Needless to say, this will be the last time I bother to shop in the area between 220 and 225 from now on. I will only take my car when I go to the bank but may change branches. I enjoy walking but it will be strictly to Valley Fair, no further.

Could this be the type of reason that downtown is seldom patronized nowadays? Surely bylaw officers could be ensuring the sidewalks are safe and used with consideration, they seem to be forever walking around ticketing parked cars. Let's prioritize efforts so that once again Maple Ridge can become the pleasant place to visit and shop, like Haney used to be. (I have lived in surroundings communities for the last forty five years.)
