INFORMED: Business Licence Renewal Time

Business Finder Application Helps Connect Citizenswith Local Business

Business licence renewals have been sent out to all businesses in Maple Ridge. There are a number of benefits to having a business licence. It allows the City to regulate the locations and types of businesses operating in the community and it assists in the development of demographic and statistical information on the local business climate.

Business licensing also supports parking enforcement, community policing and the Adopt-A-Block program. The data gathered as part of annual business licensing is also used by the Economic Development department to develop promotional materials aimed at attracting business investment and job creation within the community.

You may be eligible for the 'Inter-Municipal' Business Licence program that allows you to operate in any of the 11 communities that are part of the program. This is a great program for building contractors and other service businesses. Visit *mapleridge.ca/876* for more details.

INFORMED: Dog Licence Renewals

Dog Licences Are Due by January 31. Renew Online!

When you receive your dog licence renewal notice in the mail, look for the account number and access code that can be used to renew your dog licence online. Go to the City's website at *mapleridge.ca* and click the 'eSERVICES' button, then scroll down to the Dog License renewal section. Payment can be made by credit card or Interac from most major banks.

Remember that there is a substantial discount if you renew by January 31. Up until January 31, the licence fee is \$25 for spayed and neutered dogs and \$52 for unaltered dogs. After January 31, the licence fee is \$41 for spayed and neutered dogs and \$68 for unaltered dogs. This year, seniors (65+) get their dog licences at a 50% discount. For senior, it's \$12.50 for a licence for spayed and neutered dogs and \$26 for unaltered dogs, up until January 31. After January 31, the licence fee is \$20.50 for spayed and neutered dogs and \$34 for unaltered dogs.

Your dog's tag and receipt will be mailed to you. You still have the option of renewing by phone, by mail or in person at the Finance counter in the reception area of City Hall. Check out other online services available including the Home Owner Grant application and online access to your tax accounts. It's your 'virtual' City Hall!

Using the 'Stay Connected' link on *mapleridge.ca* provides you with access to the Notify Me feature, a 'one stop' location to sign up for notifications for Council or Committee meetings that you are interested in. By signing up for this service you are notified the minute when agendas and reports are posted, and if there are updates, you get those too.

You can also live stream council meetings as they happen by visiting **mapleridge.ca** and clicking the "Your Government"



menu, at the top of the page, then hitting the "Live Stream' link. There you will also be able to watch archived council meetings.

Property Assessment Notices

What Do You Do Now?

By now you should have received your 2019 Property Assessment Notice in the mail from BC Assessment. That document contains the assessed value of your home and property as of July 1, 2018 and that amount will be used to determine your property tax amount later this year.



You should read the document carefully and compare it to last year's notice. If you think that the value is not correct, there is a process to appeal your assessment that has to be initiated by the end of the month. Go to **bcassessment.ca** for information on how the assessment is determined, what's involved in filing an appeal, and find tools to allow you to browse home values in your area online so you can do some comparisons before you file an appeal.

There are wide variations in the values of properties depending on the dwelling type and the neighbourhood. Some people saw a drop in the value of their property and some have seen significant increases. That's why it's important to check your assessment carefully before filing it away with your other important documents. The deadline to file an appeal is January 31, 2019.
