BY-LAW NO. 2961-1981

A By-law to designate certain Public Parks as places where liquor may be consumed.

WHEREAS the Liquor Control and Licencing Act provides that a municipality may, by By-law, designate a public park, public beach or public campground over which it has jurisdiction as a place where liquor may be consumed;

NOW THEREFORE, the Municipal Council of the Corporation of the District of Maple Ridge in open meeting assembled, ENACTS AS FOLLOWS:

- 1. This By-law may be cited as "Maple Ridge Public Parks Liquor Consumption By-law No. 2961-1981".
- 2. The following Public Parks are hereby designated as places where liquor may be consumed:
 - (a) Alco Park
 - (b) Maple Ridge Park
 - (c) Whonnock Lake Park
 - (d) Albion Park
 - (e) Cliff Park
 - (f) Ruskin Park
 - (g) Selvey Park
 - (h) Thornhill Park
 - (i) Telosky Stadium
 - (j) Hammond Stadium

(m) Memorial Peace Park
