For one and two family dwellings, including additions, the permit fee shall be 15% of the building permit fee or the minimum electrical permit fee, which ever is greater. Additional charges as outlined on the electrical application form will apply when the electrical permit is taken out in conjunction with a building permit.

Fees for all other work not included above shall be based on estimated cost of work as outlined below. (com/ind/inst/multifd/ plus sheds garages sundecks, basement finishes etc.)
